

**FRANKLIN COUNTY COUNCIL MEETING**  
**October 6, 2020, at 7:00 p.m.**  
**COMMISSIONERS/COUNCIL MEETING ROOM, #203**

The Franklin County Council met for a public hearing and special meeting on October 6, 2020, at 7:00 p.m. in the Commissioners/Council Meeting Room, #203.

The meeting was called to order and the Pledge of Allegiance led by President Koch.

President Koch took roll call. Those present were Becky Oglesby, Glen Bischoff, Dean McQueen, Joe Sizemore, Joe Gillespie (zoom), Scott McDonough and Jeff Koch. A quorum was present. Karla Bauman, Auditor was also in attendance.

**Public Hearing – Ordinance 2020-24: An Ordinance establishing the 2021 Appropriations and Tax Rates:** President Jeff Koch read Ordinance 2020-24, an ordinance establishing the 2021 appropriations and tax rates. A copy of said ordinance is attached to these minutes. Auditor Bauman noted that the amount for the bond was incorrect or did not match what had been entered in Gateway and what was advertised on the Form 3. Gabe Gerth with Reedy Financial Group agreed that the amount shown on the ordinance was incorrect and requested that the adopted amount be changed to \$410,000.00. **Motion to approve Ordinance 2020-24 the 2021 Appropriations and Tax Rates for a total of \$12,097, 202.00 by Scott McDonough. Seconded by Joe Sizemore. Motion Amended – Motion to approve Ordinance 2020-24 for the 2021 Appropriations and Tax Rates with the correction of Bond #2 to \$410,000.00 (changed from \$393,900.00) for a total appropriation of \$12,096.392.00 by Scott McDonough, seconded by Joe Sizemore, all in favor, motion carried. Ayes 7 – Nays 0**

**Motion to close public hearing by Joe Sizemore, seconded by Becky Oglesby, all in favor, motion carried.**

**Special Meeting: Resolution 2020-25 – Additional Appropriations:** A special meeting was called to consider the request for additional appropriations for the Sheriff and Coroner. **Motion to approve Resolution 2020-25 by Becky Oglesby, seconded by Dean McQueen, all in favor, motion carried.**

Sara Duffy requested a copy of the tax rates that were approved. Auditor Bauman stated she would send her a copy.
