

**FRANKLIN COUNTY COUNCIL  
BUDGET ADOPTION MEETING  
OCTOBER 08,2019  
CONFERENCE ROOM, #101**

The Franklin County Council met for their 2020 Budget Adoption meeting on October 8, 2019 at 7:00 pm in Conference Room #101. Those present were Jeff Koch, Dean McQueen, Joe Sizemore, Glen Bischoff, Becky Oglesby, Joe Gillespie, Scott McDonough, and Derrike Kolb, Chief Deputy Auditor.

**OPENING:** The meeting was called to order and the Pledge of Allegiance was led by Jeff Koch.

**GABE GERTH – REEDY FINIANCIAL:** Mr. Gerth presented the changes made to the budget since the Budget Hearing. \$3,600 for County General Extension Office, New Election equipment coming out of Cumulative Capital, addition equipment for Statewide 911, and addition of CASA Grant expenditures.

**OTHER BUSINESS:** Councilmember Oglesby proposed some changes. Councilmember McDonough sated that some of the changes are already being looked into with the bond, others are already being represented in the changes Reedy made, and the other changes will be looked at a later time.

**Motion to approve Ordinance 2019-24 as presented by Councilmember McDonough, seconded by Councilmember Sizemore, 6 Yay – Koch, McQueen, Sizemore, Bischoff, Gillespie, McDonough; 1 Nay – Oglesby; Motion Carried.**




