

FRANKLIN COUNTY COUNCIL SPECIAL MEETING  
FEBRUARY 10, 2017  
COMMISSIONERS/COUNCIL MEETING ROOM, #203

Franklin County Council met in a special meeting on February 10, 2017 at 10:00 a.m. in the Council's meeting room for the purpose of responding to the 1782 Notice. Those present were President, Becky Oglesby, Dean McQueen, Joe Sizemore, Glen Bischoff, Keith Hall, Aaron Leffingwell and Karla Bauman, Auditor.

The meeting was called to order and Pledge of Allegiance led by Becky Oglesby.

Becky Oglesby explained that the purpose of today's meeting was to respond to the 1782 Notice that was recently received by the DLGF. If changes are required or requested this must be done within ten days of receiving it. When our budget requests were submitted in the Gateway system the "Requested" amount from the department heads were entered rather than the "Adopted" amounts that were approved by this council during our Budget Workshops. The changes to the Franklin County 1782 Notice for Budget Year 2017 is a little over \$2,000,000.00. The Resolution signed by County Council at the adoption hearing on October 11, 2016, for the 2017 Budget year, correctly reflected the numbers that were entered into Gateway.

The following requested revisions to Line 1C Net Budget Estimate:






Motion to Adjourn by Joe Sizemore, seconded by Dean McQueen, all in favor, motion carried.


