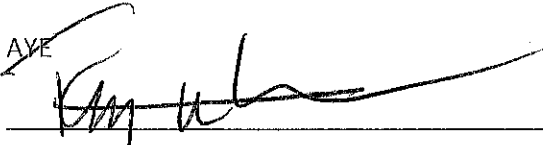

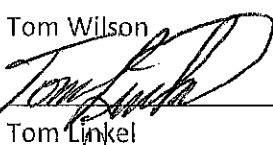
Payroll – a motion was made by Tom Linkel to approve payroll and was 2<sup>nd</sup> by Scott McDonough. Motion carried.

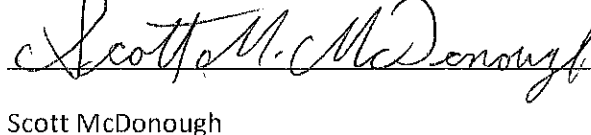
