



**FRANKLIN COUNTY COMMISSIONERS' MEETING
JANUARY 12, 2021, 10:00 A.M.
COMMISSIONERS MEETING ROOM**

The Franklin County Commissioners met on January 12, 2021, at 10:00 a.m. in the Commissioners/Council Meeting Room. Those present were Tom Wilson, Tom Linkel, Gerald Wendel, Fayette Hay and Karla Bauman, Auditor.

OPEN: The meeting was opened and pledge of allegiance was led by Tom Linkel.

Awarding of Annual Bids: Commissioners reviewed the proposed recommendations from Larry Smith, Engineer for the annual bids that were received and opened at the January 5, 2021 meeting. A copy of all bids are attached hereto.

Liquid Asphalt – Asphalt Mat. – Marathon – Terry Asphalt: Tom Linkel moved to accept all bidders and let the highway department decide who is available and lowest at the time of need, seconded by Tom Wilson, all in favor, motion carried.

Asphalt Materials – Dave O'Mara – Hot Mix, Inc. – Rohe Asphalt – Hei-Way, Inc.: Tom Linkel moved to approve all bids received, seconded by Tom Wilson, all in favor, motion carried.

Stone & Gravel – Harrison Sand & Gravel – IMI – New Point – Ballenger Stone: Tom Linkel moved to accept all bids received based on geographical and availability, seconded by Gerald Wendel, all in favor, motion carried.

Dump Truck Rental – Simmermeyer & Klump Exc: Tom Wilson moved to accept Simmermeyer and Klump Exc bids for trucking services, seconded by Gerald Wendel, all in favor, motion carried.

Pre-Engineered/Pre-fabricated Bridges - E & H Bridge – E3 Bridge: Tom Linkel moved to accept the bids from E & H Bridge and E3 Bridge, seconded by Gerald Wendel, all in favor, motion carried.

Pipe & Misc. – E3 Bridge – CivilCon – St. Regis: Tom Wilson moved to accept the bids from E3 Bridge, CivilCon & St. Regis, seconded by Gerald Wendel, all in favor, motion carried.

Designation of Infrastructure Zone within Franklin County, Ordinance 2021-01:

Commissioners reviewed Ordinance 2021-01 an ordinance for the designation of an infrastructure development zone within Franklin County, Indiana. Commissioners also received a letter from the Franklin County School Board requesting an amendment to the ordinance

requiring that a payment in lieu of taxes (PILOT) with \$4,000 being the minimum up to \$150,000. REMC is not willing to pay the school a payment in lieu of taxes. **Motion to approve Ordinance 2021-01, an ordinance designating an infrastructure development zone for broadband high-speed internet by Tom Wilson, seconded by Gerald Wendel, all in favor, motion carried.**

Board Appointments 2021: Commissioners received a letter of recommendation to appoint Karen Fuegi to the Southeastern Indiana Economic Opportunity Corporation (SIEOC). **Motion to appoint Karen Fuegi to the Southeastern Indiana Economic Opportunity Corporation by Tom Wilson, seconded by Tom Linkel, all in favor, motion carried.**

Clerk's Report – December, 2020: Motion to acknowledge receipt of the clerk's December 2020 monthly report by Tom Linkel, seconded by Tom Wilson, all in favor, motion carried.

Treasurer's Report – December, 2020: Motion to acknowledge receipt of the treasurer's December 2020 monthly report by Tom Linkel, seconded by Tom Wilson, all in favor, motion carried.

Claims: Motion to approve the claims in the amount of \$417,457.47 by Tom Linkel, seconded by Tom Wilson, all in favor, motion carried.

Community Crossing Grant: Commissioners discussed with Larry Smith, Engineer the Community Crossing Grant application that is due on January 29, 2021. At this time, they would like to apply for funds for Causeway which will short Tom Wilson's district. Our amount for that project would be approximately 1.3 million.

Perry Knox – Discussed with Commissioners the permit for Big Cedar Creek Embankment project which expires on January 31st and will need extended.




