Open: The meeting was called to order by President Becky Oglesby and opened with the Pledge of Allegiance.

Purpose: President Oglesby stated at the beginning of the meeting was to Adopt the 2016 Budget and send to DLGF.

Ordinance 2015-17: A motion was made by Daryl Kramer to approve the ordinance as submitted and was 2<sup>nd</sup> by Jeff Koch. Councilman Hall then asked four (4) questions: (1) Health Care is not in the budget, (2) Financial Risk – Judges - Community Corrections - will this have an impact on the budget. President Oglesby said that the Judge using the Home Detention and there would be no cost to the General Budget. (3) Previous Commissioners meeting: providing Health Care to Inmates at \$15.00 per inmate and there should be a reduction in the Commissioners Budget to pay for the health care and (4) Pinnacle – understanding the Commissioner decided to stay with Pinnacle until 12/30/15. There would be a consulting fee which is: first 10 hours free and after that \$300.00. Commissioner Roberts said it was his understanding the Pinnacle was going to pick this up for 2016. President Oglesby then asked for all in favor to say AYE and it was unanimous.

Adjourn: With no further business a motion was made by Daryl Kramer to adjourn and was 2<sup>nd</sup> by Dean McQueen. Motion carried.
